- 1 This form must bear the applicant's details, and it cannot be transferred to third parties. In case of underage participant, this form must be filled by a parent or legal authority with his/her own data, the latter also signs for acceptance of rules and conditions.
- 2 Application is accepted only when this form, duly filled, is received and down payment is made: € 300.00 (non refundable in case of cancellation) or total balance is received. The out standing balance must be paid as follows  
 € 750.00: 1° installment confirming inscription by March 20, 2014  
 € 750.00 balance, by May 20, 2014.  
 Please note that payments are to be only in €. (Euro).
- 3 The € 1,800.00 registration fee includes: all transportation from the arrival at Beijing Airport , by July 1<sup>st</sup>, 2014, to departure, July 15, 2014; accomodation in double room in Hotel\*\*\*\*, meals (breakfast, lunch and dinner); group lessons in the chosen programs, all the optional excursions as listed in the program upon arrival.
- 4 By registering the applicant commits to respect the general rules, as described in this form. Accordingly, the applicant must oblige to the program provisions; any change must be confirmed by organizers.
- 5 In the registration sum the following is not included: transfer to and from Beijing; extras that are not explicitly listed in the program (personal expenses, private or one-on-one lessons, longer stays; single occupancy of rooms etc..).
- 6 Cancellation for whatsoever reason must be in written, by fax or email to the addresses listed in the program.
- 7 Cancellation conditions are as follows:
  - a. within March 30, 2014 apart from the non refundable deposit of €300.00, any other downpayment shall be returned.
  - b. within April 20, 2014 apart from the non-refundable deposit of €300.00, 50% of any other downpayment shall be returned.
  - c. After April 20, 2014 down payments cannot be asked back.
 Please note that we suggest everybody to make a personal insurance against travel cancellation.
- 8 Failure to comply with the above mentioned conditions entitles the organization to resort to enforcement of law in order to protect its rights.
- 9 Any controversy shall be settled by the Court in Lugano (CH).
